Release of Liability Read Carefully - This Affects Your Legal Rights

ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY

The individual named below (referred to as "I" or "me") or the individual's child(ren) (for the purposes of this Agreement (as is defined below), child(ren) shall also mean a legal guardian's ward(s)) desires to participate in physical, recreational, and fitness activities using Company property (including without limitation bathrooms, locker rooms and showers) and Company equipment (hereinafter referred to collectively as the "Facilities") provided by The Natalia Flow LLC and Natalia Simatupang. (the "Company"). If the participant is a minor, the minor shall have no contracting rights under this Agreement (as defined below) and the minor's parent/guardian shall read, understand, and agree to each and every provision of this Agreement (as defined below) and attest to the same by affixing their signature in the appropriate location at the end of this Agreement (as defined below). As lawful consideration for being permitted by the Company to use the Facilities and the intangible value that I or my child(ren) will gain by using the Facilities, I agree to all the terms and conditions set forth in this Agreement (the "Agreement").

I VOLUNTARILY AGREE TO ASSUME ALL OF THE FOREGOING RISKS AND ACCEPT SOLE RESPONSIBILITY FOR ANY INJURY TO MYSELF AND/OR MY CHILD(REN) (INCLUDING, BUT NOT LIMITED TO, PERSONAL INJURY, DISABILITY, AND DEATH), ILLNESS, DAMAGE, LOSS, CLAIM, LIABILITY, OR EXPENSE, OF ANY KIND, THAT I AND/OR MY CHILD(REN) MAY EXPERIENCE OR INCUR IN CONNECTION WITH USING THE FACILITIES ("CLAIMS"). I HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, AND HOLD HARMLESS THE COMPANY, ITS EMPLOYEES, AGENTS, AND REPRESENTATIVES, OF AND FROM THE CLAIMS, INCLUDING ALL LIABILITIES, CLAIMS, ACTIONS, DAMAGES, COSTS OR EXPENSES OF ANY KIND ARISING OUT OF OR RELATING THERETO. I UNDERSTAND AND AGREE THAT THIS RELEASE INCLUDES ANY CLAIMS BASED ON THE ACTIONS, OMISSIONS, OR NEGLIGENCE OF THE COMPANY, ITS EMPLOYEES, AGENTS, AND REPRESENTATIVES.

I FURTHER KNOWINGLY AND VOLUNTARILY WAIVE AND RELINQUISH ALL RIGHTS AND BENEFITS UNDER CALIFORNIA CIVIL CODE SECTION 1542, WHICH PROVIDES:

"A GENERAL RELEASE DOES NOT EXTEND TO CLAIMS THAT THE CREDITOR OR RELEASING PARTY DOES NOT KNOW OR SUSPECT TO EXIST IN HIS OR HER FAVOR AT THE TIME OF EXECUTING THE RELEASE, AND THAT IF KNOWN BY HIM OR HER, WOULD HAVE MATERIALLY AFFECTED HIS OR HER SETTLEMENT WITH THE DEBTOR OR RELEASED PARTY."

THIS AGREEMENT PROVIDES THE COMPANY WITH MY ABSOLUTE AND UNCONDITIONAL CONSENT, WAIVER, AND RELEASE OF LIABILITY ARISING OUT OF MY AND/OR MY CHILD(REN)'S TAKING CLASSES INSTRUCTED BY NATALIA SIMATUPANG AND EMPLOYEES, AGENTS, AND REPRESENTATIVE OF THE NATALIA FLOW LLC. BY SIGNING BELOW, I ACKNOWLEDGE THAT I HAVE READ AND I FULLY UNDERSTAND ALL OF THE TERMS OF THIS AGREEMENT AND THAT I AM VOLUNTARILY GIVING UP SUBSTANTIAL LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE THE COMPANY FOR CLAIMS, WHETHER KNOWN OR UNKNOWN, WITH RESPECT TO INJURIES, AND HEALTH

In addition I agree to the following terms and conditions regarding my participation in fitness classes at The Natalia Flow LLC with Natalia Simatupang:

- 1. Agreement to follow directions. I agree to observe and obey all posted rules and warnings, and further agree to follow any oral instructions given by instructors, or the employees, representatives or agents of The Natalia Flow LLC.
- 2. Assumption of the risks and release. I recognize that there are certain inherent risks associated with the above described activity, and I assume full responsibility for personal injury to myself and further release and discharge The Natalia Flow LLC, Natalia Simatupang, and associated instructors for injury, loss, or damage arising out of my use of or presence upon the facilities of The Natalia Flow LLC, whether caused by the fault of myself, or other third parties.
- 3. Indemnification. I further acknowledge and agree that I am free to have my own legal counsel review this Agreement if I so desire. I further agree and acknowledge that The Natalia Flow LLC. has offered to refund any fees I have paid to use its facilities if I choose not to sign this Agreement.
- 6. Dispute Resolution. The parties will attempt to resolve any dispute arising out of or relating to this Agreement through friendly negotiations amongst the parties. If the matter is not resolved by negotiation within 30 days, the parties will resolve the dispute by binding arbitration under the rules of the American Arbitration Association. The arbitrator's award will be final, and judgement may be entered upon it by any court having proper jurisdiction.
- 7. I agree to allow The Natalia Flow LLC. and Natalia Simatupang to use images or video of my participation in classes or events for promotional and marketing purposes unless I specifically request to have my images excluded.
